An owner of property that is a "Principal Residence" on May 1 may appeal to the July BOR in the year for which an exemption was claimed or in the immediate succeeding three years if the exemption was not on the tax roll. For taxes levied after December 31, 2011, an owner who owned and occupied a principal residence on June 1 or November 1 for which the exemption was not on the tax roll may file an appeal with the July or December BOR in the year for which the exemption was claimed or in the immediate succeeding three years if the exemption was not on the tax roll. An owner of a property that is Qualified Agriculture Property on May 1 may appeal to the July BOR |

for the current year and the immediately preceding year if the exemption was not on the tax roll. July BOR may hear appeals for current year only for poverty exemptions, but not poverty exemptions denied by the March BOR.

12/12/17 10:00 a.m. Purpose to correct qualified errors. An owner of property that is "Principal Residence" on May 1 may appeal to the December BOR in the year for which an exemption was claimed or in the immediate succeeding three years if the exemption was not on the tax roll. An owner cannot appeal to the December BOR if property was owned and occupied as a principal residence some time from May 2 to November 1 but form 2368 was not timely filed. An owner of property that is Qualified Agricultural Property on May 1 may appeal to the December BOR for the current year and the immediately preceding year if the exemption was not on the tax roll. December BOR may hear appeals for current year poverty exemptions only, but not poverty exemptions denied by the March BOR. Contact Assessment Department for any additional information.
