Charter Township of Flint 4 YEAR IMPROVEMENT PLAN For the Local Road System 2013-2016

Introduction

The following is the proposed Road Improvement Plan for Charter Township of Flint. Although the Plan focuses on the local road system, including limestone roads and the ditches that are integral part of the system, it also encompasses Primary Roads. It does so because, while improvements on the Primary system are prioritized by the Genesee County Road Commission, they are subject to inclusion in the County-wide Transportation Improvement Plan (TIP) and largely beyond the Township's control, the Primary system is a significant part of the Township's transportation system.

Charter Township of Flint is adopting this 4 Year Local Road Plan to assist in the prioritization of its Local road maintenance and construction program. The overarching goal of the plan is to slow the deterioration of the road network. This plan can be revised each fiscal year. During the process of developing the plan several issues are considered. Priorities for chip sealing roads within the townships road network are reassessed each year.

Roads are reviewed and the plan updated annually since some roads may deteriorate quicker than expected, while others may be able to be deferred. Flint Township Road Advisory Committee, with the assistance of Genesee County Road Commission has established a priority system road network. Priorities for these roads are set based on traffic volumes, crash history and the year material was last added. This plan will help the advisory committee in making their recommendations to Township Board to ensure that adequate maintenance is undertaken on its local road network each year.

This plan is divided into three (3) sections and an appendix.

Section 1. Provides an overview of the township, its road systems and what the township anticipates to accomplish with its Road Improvement Plan.

It describes the trend of the surface condition of the local roads over the past several years. It briefly describes the criteria officials used to select projects.

Section 2. Contains a list of all the Paved Local and Primary Roads in the Township.

Sorted by PASER (Road Rating System) Rating, which is also briefly described here. These lists are useful in helping determine which Local roads and Primary roads the Township and the Road Commission respectively will work on in each year of the plan. Because the lists contain all roads, they help illustrate the "BIG PICTURE" of road conditions in the Township.

Section 3. List of proposed projects sorted by year and type of improvement to be done.

For the Primary roads system, which is completely maintained by the Road Commission, the list contains only those projects which have been selected and prioritized by the Road commission and chosen for inclusion in the County wide TIP. Some might consider this section to be the actual "plan".

The Plan also includes Appendixes, which contains a listing of the various "fixes" that were considered for the roads in the Paved Local Road System (PASER). Also included is "Bylaws of The Charter Township Flint Road Advisory Committee".

It is included to show the great variety of maintenance techniques that are available, and the PASER rating of each segment is used to select appropriate fixes. This list also shows the wide range in the cost of these fixes. And makes the value of the comparatively low cost "preservation" techniques quite clear. This is an asset management approach to road maintenance which considers "the right fix at the right place at the right time."

SECTION 1 Background

Roads in Charter Township of Flint can be looked at several different ways. One way is by Act 51 Designation. That is, whether the road is a State trunk line, a County Primary Road or a County Local Road.

Act 51 Designation

In Charter Township of Flint, as in most of the townships in Genesee County, there are many more County Local road miles than County Primary miles. This is significant because County Primary roads are eligible for Federal Aid funding while County Local roads are not. Furthermore, state law requires that some entity other than the Genesee Road Commission pay at least 50% of the cost of major reconstruction projects on local roads. In this report, which focuses on the local road network, local roads are defined as all public County roads that are outside incorporated cities and villages and are not eligible for federal aid funding.

In Charter Township of Flint there are 34.73 miles of State Trunkline, 42.41 miles of County Primary, and 171.14 miles of County Local.

Subdivision Streets

Another useful way to look at local roads in Genesee County is to consider whether they are subdivision (neighborhood, residential) streets, or the more "mainline" local roads (the mile-type roads). The subdivision streets typically provide more of an access to property function while the mainline local roads function more as through streets. It is important to make this distinction because subdivision streets are built to different standards, have their own usage and wear patterns, and are funded differently than the mainline local roads.

Although the township share's responsibility with the Genesee Road Commission for both mainline local roads and subdivision streets, the Road Commission spends Act 51 maintenance funds to maintain the mainline locals, while maintenance of the subdivision streets is largely the responsibility of the township and the residents. The Road Commission pays only for engineering and inspection of subdivision streets. Nearly all maintenance on these roads is paid by special assessment and/or road millage funds by the adjacent property owners. In Charter Township of Flint, over 68.2% of the Local Road mileage is Subdivision streets.

Surface Type

The road network can also be divided by surface type. Roads may be "paved", meaning they are hard surfaced with asphalt or concrete (or brick in a few cases, or composite), or they may be "unpaved", surfaced with gravel, limestone, dirt or earth. This is important when considering PASER ratings, because while paved roads generally follow a fairly well established deterioration process over time, unpaved roads do not. Unpaved roads can change significantly in a very short time under certain conditions of weather and use. For such unstable surfaces, comparison of PASER rating over time is meaningless, and prediction of future surface condition on these roads is impossible.

For this reason the Asset Management Council decided not to collect PASER data on unpaved roads. The Genesee County Road Commission agrees with this position, and beginning in 2006 rates only its paved road system. This is worth noting, particularly when you consider that such a large percentage of the roads in some townships are unpaved. In Charter Township of Flint approximately 83.6% of the Local road system are paved.




Trend

Local roads in Charter Township of Flint, like many roads in Michigan, have seen some deterioration over the past decade as lack of adequate funding resulted in delayed or deferred maintenance, Road maintenance done as a result of careful stewardship of limited funding did keep many paved local roads in a condition where further preservation techniques are still possible.

The following graphs show the condition of the Township's Local and Primary roads systems from 2006 through 2012 as reflected in the percent of the system rated Good (PASER 8-10, green), Fair (PASER 5-7, blue), and Poor (PASER 1-4, red). The Local road system was not rated in 2010, as indicated by the yellow bar for that year in the top graph.

Flint Township Surface Condition Trend 2006 – 2012






The following is a list of all the Paved Local roads in the township, sorted by 2012 PASER rating. Unpaved (limestone/gravel) roads are not included on the list because they are not rated. The Michigan Transportation Asset Management Council (TAMC) which promotes and oversees the use of the PASER rating system determined several years ago that because the condition of some unpaved roads can change literally overnight. Nevertheless, unpaved roads are a significant part of the Township's Local road system therefore, are included in part of this Plan.

The following is a list of all primary roads in the Township, sorted by the Road Commission's project Priority Scoring System. In addition to PASER rating, this system takes into account the traffic volume on the segment (which isn't usually available for Local roads) and the year of last improvement. The Road Commission selects candidate projects from this and presents them to the County Metropolitan Planning Commission (MPO) where they compete for federal aid funding and inclusion on the County-wide Transportation Improvement Program (TIP) with projects presented by the various cities and villages and the Michigan Department of Transportation. Given this lack of Township control of funding for these roads, they cannot be included in the listing of Local road system projects in this plan.



Note 2: CDBG Funds that are available will be used for ditching as per the advice of the Supervisor of the GCRC Swartz Creek garage and allowed under CDBG guidelines.

Note 3: 242 money are funds that the Township receives for various ditching projects and projects are determined by the GCRC Swartz Creek garage.

The Road millage sets funds each year out of the budget for ditching and those funds for ditching are estimated dollars from the Income/expenses projection of Road Millage Funds Report







The following charts compare the projected condition of the Charter Township of Flint Local Road System under two different scenarios, "Do Nothing" vs. the "Preservation" approach proposed in this plan. Clearly the Do Nothing approach is unacceptable, since by 2016 nearly 100% of the local road system will be in Poor condition (red) and require full reconstruction. With the Plan's preservation approach on the other hand, roads are kept in Fair (blue) condition and the condition of the overall Local road System is slowly improved until by 2016 less than 75% of the system is in Poor condition. Then, heavier construction activities undertaken at the end of this Plan period will return roads in poor condition to Good condition and green will start show a remarkable increase.






Summary

The intent of this plan is to guide Charter Township of Flint officials in a strategy of preservation of the Local Road System. It is a strategy of preserving paved roads that are still in Fair condition while the Township builds up funds to do more heavy reconstruction of that have PASER ratings of 4 or lower.

The following graph of the Remaining Service Life (RSL) of the Local road network illustrates the success of the Plan's preservation approach. It show that this approach accomplishes what the Township set out to do -- preserve the Local Road System in a smooth and safe condition until it can be systematically rebuilt. (A road's RSL is considered to be 0 when it reaches its Critical Distress Point, which is a PASER Rating of 4. That's is how the average RSL of the local road network is a minus 5.0 in 2013). The preservation approach (the blue Line) essentially keeps the RSL steady moving up from 2013 to 2016, the Do Nothing Approach would allow it to decrease during this same time period.



Appendix

Appendix A PASER ROAD RATING SYSTEM

This section describes the PASER Road Rating System including a brief description of the various fixes indicated by the rating numbers, and the per mile cost of each treatment.

PASER is a surface condition rating system developed by the University of Wisconsin and used in Michigan since 2004. Roads are rated on a 1-10 scale based on the surface distresses visible to trained rater, where 10 is a newly constructed or reconstructed road and a 1 is a road that has completely deteriorated.

Roads with PASER ratings of 1-4:

These roads require Structural Improvements. This category includes work identified as rehabilitation and reconstruction, which address the structural integrity of the road. These are typically large, expensive projects necessary when the road has reached or is near the end of its service life.

Roads with PASER ratings of 5-7:

These roads require Capital Preventive Maintenance. Capital preventive maintenance is defined as a planned set of cost effective treatments to an existing roadway system and its appurtenances that preserves, retards future deterioration and maintains or improves the functional condition of the system without significantly increasing structural capacity. The purpose of capital preventive maintenance is to protect the pavement structure, slow the rate of pavement deterioration and/or correct pavement surface deficiencies. Surface treatments are targeted at pavement surface defects primarily caused by the environment and by pavement material deficiencies.

Roads with PASER ratings of 8-10:

These roads require only Routine Maintenance. Routine maintenance is the day-to-day scheduled maintenance activities, such as street sweeping, drainage clearing, shoulder gravel grading, and crack sealing.

Cost per Mile - APPENDIX "B"

The cost per mile of the various types of fixes indicated by each of the PASER Ratings (1-10) is presented in the table below. Note that as the road deteriorates, as indicated by lower PASER ratings, the cost of the fixes goes up substantially. much more extensive – and expensive – repairs are available for each of the PASER ratings.

Appendix C Charter Township of Flint Road Advisory Committee

Mission: On August 8, 2006, Voters of the township passed "Flint Township Road Millage Proposal".

"Shall the authorized charter millage and tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution on general ad valorem taxes within the Charter Township of Flint, Genesee County, Michigan, be increased for said Township in an amount not to exceed .5 mill (\$.50 on each \$1,000 of taxable value) against all taxable real and tangible personal property for a period of ten (10) years, 2006 to 2015, inclusive to provide funds for road maintenance and improvement; and shall the township levy the Charter township of Flint will collect if the millage is approved and levied by the Township in the 2006 calendar year is approximately \$566,800".

The By-Laws for this committee (<u>Appendix C-1</u>) contain name of committee, and its purpose. Qualification of members. Officers, their election and duties. Meetings of the committee and how to amend the by-laws.

BYLAWS

OF

THE CHARTER TOWNSHIP OF FLINT ROAD ADVISORY COMMITTEE

Article One Name, Location and Offices

- 1.1 Name. The name of the Committee shall be the Road Repair Advisory Committee, (hereinafter referred to as the "Committee.")
- 1.2 Office and Records. The Committee shall use the Charter Township of Flint, (hereinafter referred to as the "Township"), Township Hall for its meetings. The Township Clerk shall keep Committee records.

Article Two Purpose

- 2.1 <u>Purpose.</u> The Committee was organized to study how and where the Township should spend funds it receives from a 0.5 millage passed August 8, 2006 for the purpose of improving and maintaining roads within the Township. The Committee shall periodically, or when requested by the Township Board of Trustees, report in writing to the Township Board the results of its study.
- 2.2 <u>Governing Instrument.</u> The Committee was formed pursuant to a resolution passed by the Township's Board of Trustees on March 19, 2007. The Committee is not a corporate body politic separate from the Township. The Committee has no authority to render any decision regarding public policy.
- 2.3 <u>Duration</u>. The Committee shall exist at the pleasure of the Township's Board of Trustees and may by vote of that Board be terminated at any time for any reason or for no reason.

Article Three Members

- 3.1 <u>Number.</u> There shall be nine members of the Committee, one of which shall be the Township's Supervisor. The Township Board of Trustees shall appoint the remaining eight members.
- 3.2 <u>Term:</u> The term of the eight appointed members shall expire December 31, 2016. Subsequent appointments shall be for a term of three years. The person occupying the position of Township Supervisor shall serve as an ex officio member of the Committee without a term and without a vote unless necessary to break a tie. There is no limit to the number of successive terms a member may serve. The terms here specified assume the continued existence of

the Committee. Should the Committee be terminated pursuant to Section 2.3 the terms of the members shall be also be terminated effective at the same time as the termination of the Committee.

- 3.3 <u>Removal.</u> Other than the Supervisor the Township Board of Trustees may, for cause, remove any member.
- 3.4 <u>Vacancies.</u> Any vacancy on the Committee, other than Supervisor, arising any time and from any cause may be filled for the unexpired term by the Township's Board of Trustees. Each member so appointed shall hold office until the expiration of his/her term, or the unexpired terms of his/her predecessor, as the case may be, and until his/her successor is appointed.
- 3.5 <u>Conflict of Interest.</u> A member who has a direct or indirect personal or financial interest in any matter before the Committee shall disclose his or her interest prior to any discussion of the matter by the Committee, which disclosure shall become part of the record of the Committee's meeting. The disclosure shall be made by written instrument. The interested member shall further refrain from participation in the Committee's action relating to the matter.

Article Four Meetings of the Committee

- 4.1 Regular Meetings. Meetings of the Committee shall be held when called by the Chairperson. Notice of the time and place of each meeting shall be given by the Secretary either personally or by telephone or by mail not less than three nor more than thirty days before such meeting. The meetings of the Committee shall be public and the appropriate notice of such meetings provided to the public. Notice of all meetings of the Committee shall be given in accordance with the Open Meetings Act, 1976 P.A. 267, as amended.
- 4.2 Quorum. A majority of the Committee shall be required to constitute a quorum for the transaction of business. The Committee shall act by a majority vote of those entitled to vote at which a quorum is present.
- 4.3 <u>Conduct of Meetings.</u> The conduct of all meetings shall be in accordance with these Bylaws, the statutes of the State of Michigan and Robert's Rules of Order Newly Revised. The Committee may decide upon rules other than Robert's.

Article Five Officers

5.1 <u>Number and Qualifications.</u> The officers of the Committee shall be a Chairperson and a Secretary. The Chairperson of the Committee shall be the Supervisor of the Township. The Secretary shall be selected by a majority vote of the members of the Committee entitled to vote.

5.2 <u>Chairperson.</u> The Chairperson shall call and preside over all meetings of the Committee.

5.3 Secretary.

- (a) The Secretary shall attend all meetings of the Committee and record all votes, actions and the minutes of all proceedings in a book to be kept for that purpose. The book shall be kept in the office of the Township Clerk.
- (b) The Secretary shall give, or cause to be given, notice of all meetings of the Committee.
- (c) The Secretary shall be responsible for written correspondence with other group's or persons as directed by the Chairperson. All communication received by the Secretary shall be brought to the attention of the Committee at the meeting following receipt of the communication.
- (d) The Secretary shall be responsible for maintaining an attendance record for each member of the Committee and shall report those records annually to the Chairperson.
- (e) The Secretary shall preside over any meeting which the Chairperson is unable to attend.


Article Six Miscellaneous

- 6.2 <u>Contracts.</u> The Committee may not enter into any contract or execute and deliver any instrument in the name of and on behalf of the Committee.
- 6.3 <u>Amendments.</u> These bylaws may be amended only by the Township's Board of Trustees.
