Motion to approve the second reading of the ordinance creating the Charter Township of Flint's Downtown Development Authority.

DOWNTOWN DEVELOPMENT AUTHORITY ORDINANCE CHARTER TOWNSHIP OF FLINT

ORDINANCE NO. 030518DDA

An Ordinance to establish a Downtown Development Authority in the Charter Township of Flint, Genesee County, Michigan, pursuant to Act 197 of the Public Acts of Michigan of 1975, as amended; to define the boundaries of the Downtown District constituting the Downtown Development Authority; to provide for other matters necessary and related to the Downtown Development Authority; and to provide for the effective date of this Ordinance.

THE CHARTER TOWNSHIP OF Flint, Genesee COUNTY, MICHIGAN, ORDAINS:

Sec. 1 TITLE

This Ordinance shall be known and may be cited as the "Downtown Development Authority Ordinance."

Sec. 2 DEFINITIONS

In the enforcement and interpretation of this Ordinance, words that are defined in Act 197 shall have the meaning as given them in Act 197, and the following words, terms, or phrases are defined as stated below, unless specifically stated otherwise in context.

- 2.01 Authority. The Downtown Development Authority of the Charter Township of Flint, as created by this Ordinance.
- 2.02 Act 197. The Downtown Development Authority Act, Act 197 of the Public Acts of Michigan of 1975, as amended.
- 2.03 Board or Board of Directors. The Board of Directors of the Authority.
- **2.04 Business District.** The business district as designated in this Ordinance, and as may be amended pursuant to Act 197.
- 2.05 Supervisor. The Supervisor of the Township.
- 2.06 Township. The Charter Township of Flint, Genesee County, Michigan.
- 2.07 Township Board. The Board of Trustees for the Charter Township of Flint.

Sec. 3 PURPOSE AND FINDINGS

The Township Board of the Charter Township of Flint determines and finds that it is necessary for the best interests of the Township to create a public body corporate in order to halt property value deterioration and increase property tax valuation where possible in the Downtown District, to eliminate the causes of the deterioration, and to promote economic growth, pursuant to Act 197.

Sec. 4 CREATION OF AUTHORITY

Pursuant to Act 197, there is created a Downtown Development Authority for the Township. The Authority shall be a public body corporate. The Authority may adopt a seal, may sue and be sued in any court of this State, and shall possess all of the powers necessary to carry out the purpose of its incorporation as provided herein and in Act 197. The enumeration of a power in this Ordinance or in Act 197 shall not be construed as a limitation upon the general powers of the Authority.

Sec. 5 DESCRIPTION OF DOWNTOWN DISTRICT

The Downtown Development District in which the Authority shall exercise its power as provided by Act 197 shall consist of the property in the Township described on Exhibit A attached to and made a part of this Ordinance, subject to such changes or amendments as may be made pursuant to this Ordinance and Act 197.

Sec. 6 BOARD OF DIRECTORS

The Authority shall be under the supervision and control of the Board of Directors consisting of the Supervisor and ten members. The members shall be appointed by the Supervisor subject to approval by the Township Board. Eligibility for membership of the Board of Directors and terms of office shall be as provided by Act 197. Each member shall hold office until the member's successor is appointed.

Sec. 7 POWERS OF THE AUTHORITY

The Authority shall possess all of the powers necessary to carry out the purposes of its incorporation and shall have all the powers provided by Act 197. It shall provide the Township Planning Department and the Township Planning Commission all reports and studies regarding the formulation and implementation of project development plans. The Authority shall also secure approval of development plans from the Township Planning Commission prior to implementation of any plans thereof. 7.01 In the course of preparing and submitting a Tax Increment Financing Plan, the Authority may enter into agreements with the taxing jurisdictions in which the Business District is located and the Township Board to share a portion of the captured assessed value of the Business District, as permitted in Section 14 of Act 197.

Sec. 8 FISCAL YEAR; ADOPTION OF BUDGET; REPORTS; AUDITS

- **8.01.** The fiscal year of the Authority shall begin on January 1 of each year and end on December 31 of the same year, or such other fiscal year as may be adopted by the Township.
- 8.02. The Board of Directors shall annually prepare a budget and shall submit it to the Township for consideration by the Township Board. The Board of Directors shall not finally adopt a budget for any fiscal year until the budget has been approved by the Township Board. The Boards of Directors may, however, temporarily adopt a budget in connection with the operation of any improvements which have been financed by revenue bonds where required to do so by the Ordinance authorizing the revenue bonds.
- 8.03. The Authority shall be audited annually by the same independent auditors auditing the Township and copies of the audit report shall be filed with the Township Board.

Sec. 9 TERMINATION

Upon completion of its purposes the Authority may be dissolved by an Ordinance duly adopted by the Township Board. The property and assets of the Authority, after dissolution and satisfaction of its obligations, shall revert to the Township.

Sec. 10 SECTION HEADINGS; SEVERABILITY; REPEALER

Section headings are provided for convenience only and are not intended to be a part of this Ordinance. If any portion of this Ordinance shall be held to be unlawful, the remaining portions shall remain in full force and effect. All Ordinances and parts of

Ordinances in conflict with this Ordinance are repealed to the extent of such conflict.

Sec. 11 PUBLICATION; RECORDING; FILING

After its adoption, this Ordinance shall be published once in full in a newspaper of general circulation in the Township, and the Township Clerk shall file a certified copy of the Ordinance with the Michigan Secretary of State promptly after its adoption.

Sec. 12 EFFECTIVE DATE

This Ordinance was approved and adopted by the Township Board of Flint Charter Township, Genesee County, Michigan, on March 5, 2018. This Ordinance shall become effective on the first day following its publication in a newspaper of general circulation within Flint Charter Township.

At a regular meeting of the Charter Township of Flint Board, held on March 5, 2018, at 7:00 p.m., where a majority of the Township Board was present, the following Resolution was offered by Trustee Frank Kasie and supported by Trustee Tom Klee.

WHEREAS, The State of Michigan Corridor Improvement Authority Act P.A. 280 of 2005, as amended, authorizes a township to establish a Corridor Improvement Authority which can encourage historic preservation, acquire and dispose of interests in real property and authorize the creation and implementation of development plans designed to promote economic growth within commercial areas of a township; and

WHEREAS, The Flint Township Board has discussed the need for such an authority to encourage the economic growth of the commercial area residing in the Township; and

WHEREAS, A resolution of intent was approved by the Township Board indicating that the jurisdictional area meets certain legislative requirements of Sections 6 and 22 of the Act, and that resolution also set a date and time for a public hearing concerning establishment of the Corridor Improvement Authority: and

WHEREAS, A public hearing was held on Monday December 18, 2018 at 7:00 pm at Flint Township Hall in accordance with Public Act P.A. 280 of 2005, as amended, which requires the Township Board to give proper public notice for a public hearing prior to establishing the Corridor Improvement Authority; and

WHEREAS, Comments were received on the establishment of the CIA and placed on the official record of the township, and subsequent changes were made to the CIA boundaries; and

WHEREAS, The Township Board of Trustees of Flint Township finds that:

- 1. There is a public need to establish a Corridor Improvement Authority which can encourage historic preservation, acquire and dispose of interests in real property and authorize the creation and implementation of development plans designed to promote economic growth within commercial areas of the Township.
- 2. That the proposed jurisdictional area of the authority:
- (a) Is adjacent to or is within 500 feet of a road classified as an arterial or collector according to the federal highway administration manual "Highway Functional Classification Concepts, Criteria and Procedures".
- (b) Contains at least 10 contiguous parcels or at least 5 contiguous acres.
- (c) More than 1/2 of the existing ground floor square footage in the development area is classified as commercial real property under section 34c of the general property tax act, 1893 PA 206, MCL 211.34c.
- (d) Residential use, commercial use, or industrial use has been allowed and conducted under the zoning ordinance or conducted in the entire development area, for the immediately preceding 30 years.
- (e) is presently served by municipal water or sewer.
- (f) is zoned to allow for mixed use that includes high-density residential use.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF THE CHARTER TOWNSHIP OF FLINT AS FOLLOWS:

- 1. That the Township Board of Filnt Charter Township, Genesee County, Michigan, herewith creates the Bristol Road Corridor Improvement Authority with the boundaries outlined in the attached description and map
- 2. That the Township Board of Flint directs the township clerk to file a copy of the resolution with the secretary of state and to publish it at least once in a newspaper of general circulation.
- 3. That the Township Board of Flint agrees to:
- (a) To expedite the local permitting and inspection process in the development area as part of the CIA implementation effort.
- (b) To modify its master plan to provide for walkable non-motorized interconnections, including sidewalks and streetscapes throughout the development area.
