The following Resolution was offered by Treasurer Klee and supported by Trustee King.

**RESOLUTION REGARDING SPECIAL ASSESSMENT DISTRICT  
FOR FIRE PROTECTION SERVICES**

WHEREAS, the Township operates a Fire Department and finances fire protection services through a general operating line item in its budget;

WHEREAS, due to cuts in State revenue sharing and lower tax revenue due to depressed property values, the Township is concerned about its ability to maintain the same level of fire protection services absent additional sources of revenue;

WHEREAS, the Township Board is tentatively interested in financing fire protection services it provides through a special assessment pursuant to PA 33 of 1951;

NOW, THEREFORE, THE FLINT TOWNSHIP BOARD HEREBY RESOLVES AS FOLLOWS:

1. The Township Board tentatively declares its intent to finance fire protection services by a special assessment district consisting of all parcels in the Township subject to the collection of taxes under the General Property Tax Act;
2. The Township Board directs the Supervisor or her designee to estimate the costs and expenses of maintaining fire protection services throughout the Township and to file them with the Township Clerk where they shall be available for inspection or copying upon request.
3. The Township Board shall hold a hearing on February 26, 2024, at 6 p.m. at the Central Church of the Nazarene, 1261 Bristol Road, Flint, Michigan 48507, to hear comments or objections about the (1) costs and estimates of providing fire protection services; (2) establishment of a special assessment district to finance those services, that district to consist of all parcels in the Township subject to the collection of

taxes under the General Property Tax Act; and (3) special assessment being a levy of up to 4 mills of the taxable value of all assessed parcels.

4. Notice of this hearing shall be published in a newspaper of general circulation in the Township no less than five (5) days before the hearing.

At a regular meeting of the Board of Trustees for the Township of Flint held on February 5, 2024, T. Klee moved for adoption of the foregoing resolution and G. King supported the motion.
